Rules and Directives.





The Pharr Police Training Division strives to provide professional and quality training for all personnel; therefore, it is imperative to maintain a professional learning environment that allows this learning process.

- 1. All students must be in class on time.
- 2. Tobacco products are not allowed in the training area.
- 3. Profane or offensive language is prohibited.
- 4. Food is to be consumed only during breaks and in the kitchenette area.
- 5. Students will maintain professional demeanor while attending a class.
 - A) Sleeping in class will not be tolerated. (Standing up will help)
 - B) Disrespect towards any instructor or guest speaker will not be tolerated.
 - C) Use of cellphones during class is to be kept to a minimum, if necessary, please take call outside classroom.
- 6. Rules of attire:
 - A) No sleeveless or cut off T shirts.
 - B) All shirts must have a collar (Dress or Polo shirts).
 - C) No shirts with offensive or vulgar words or markings.
 - D) No shirts with a neck line lower that 3 inches form Neck.
 - E) No shorts of any type.
 - F) No pants that fall lower than the waistline.
 - G) No Jeans.
 - H) No spandex or warm ups.
 - I) No sandals of any kind.
 - J) No caps, hats.
 - K) PPD Employee may wear his/her assigned Uniform with the weapon hip holstered and badge.





- L) The instructor may order the attire of the day for classes, depending on the nature of the training.
- M) All Persons attending training at the Pharr Police department must adhere to these rules.

*Pharr Police Department personnel will abide by City Policy Chapter 45 Dress code, Section 7: Employees who are not appropriately attired may be counseled and requested by a supervisor to return home and change into appropriate attire. Violation of this dress code policy can serve as grounds for disciplinary Action.
